

## **RULES FOR BURLINGTON HUMANE SOCIETY LOVE THE ANIMALS LOTTERY 2019-2020**

Proceeds of the lottery will be used for veterinary services for the animals in the care of Burlington Humane Society.

### **1. Eligibility**

Those members of the charity who are on the board of directors, are conducting the LOTTERY event, including ticket sales or are listed as principal officers on the licence application are not permitted to purchase tickets in the draw.

- a. Lottery tickets shall not be sold to a person under the age of 18 years old. Tickets cannot be ordered in the name of a minor.
- b. If the winning ticket proves to be a person under the age of 18 years of age, the prize will be held in trust until the winner is of legal age to claim the prize.
- c. Tickets will be sold only in the Province of Ontario and the purchaser must be a legal resident of Ontario.

### **Tickets**

- a. 5000 tickets will be available for sale at \$5.00 each or 5 for \$20.00. Ticket numbers will be issued in sequential order. Ticket purchases are not tax deductible.
- b. Tickets will be sold by cash, cheque, debit or credit at Burlington Humane Society, 740 Griffith Court, Burlington and tickets will be given to the purchaser.
- c. Phone or mail orders (form available online to be printed by purchaser) may be purchased by credit card or cheque. Dishonoured cheques – person will be phoned to replace cheque with a credit card or cash. They are required to pay any NSF fees according to the bank.
- d. **NEW** – Online tickets will be sold by credit card payment through the Burlington Humane website at [burlingtonhumane.ca](http://burlingtonhumane.ca)
- e. The official ticket is a receipt of purchase. It is the responsibility of ticket purchasers to ensure they receive their tickets; however participants do not need their ticket/s in hand in order to be included in the respective draw(s).

- f. Official tickets will be delivered to the customer via email and/or letter mail. For all ticket orders where a valid email is provided, the official ticket receipt will be provided by email within 3-5 business days. Where no email address is provided, official ticket receipts will be mailed. Ticket purchasers may request a physical copy of their ticket(s) at time of purchase or by calling BHS at 905-637-7325 during normal business hours. Physical tickets will be mailed to the address provided at the time of the order within 7-10 business days.
- g. Ticket sales will close as of January 18, 2021 for payments being made by cheque to ensure the cheque payment clears. Ticket sales will close as of January 31, 2021 at 11 a.m. for payments by cash or credit card. Once tickets are sold – there will be no refunds.

### **Draw Dates**

- h. Draw Date: Early bird draw on December 18, 2020 – prize of \$500.00.  
Daily draws from January 1 – 30, 2021 – prize per day \$100.00.  
Grand prize draw on January 31, 2021 – prize of \$3,000.00.  
32 draws total.

Draws will be held at BHS at noon on the dates listed on the lottery licence.

All tickets will be re-entered into consecutive draws – ticket purchasers have a chance to win multiple prizes.

- i. The winning ticket will be drawn manually by a neutral third party who does not have a ticket in the draw. Only the person making the draw will put their arm into the barrel and will not have clothing on their arm below their elbow.
- j. The ticket container will be shaken or spun (minimum of 5 spins) to ensure an equal chance for all ticket purchasers to win the designated prize.
- k. The winners do not have to be present to win their prizes.
- l. The raffle chair person will use all the available means to contact the winners. The winner has up to 6 months to claim their prize.  
The winner must present valid identification to the charity to claim the prize.  
All prize winners will be posted on the Burlington Humane Society's website.
- m. By accepting the prize, winners agree to hold sponsors, its agencies, affiliates, subsidiaries, agents, advertising and promotion agencies, and anyone else involved in the development, production or handling of the raffle (lottery) and their respective directors, officers, employees, volunteers and assigns, harmless against any and all claims and liability arising out of use of prize. Decisions are final on all matters relating to this raffle. By participating in the raffle, entrants agree to be bound by these Official Rules.
